Introduction

This document has been created by the Pixel project with the purpose to provide a framework for the organisation of Educational Workshops focused on the access and use of blockchain and NFTs for Cultural and Creative Industries (CCIs).

The workshops, guided by experts in blockchain and digital transition for CCIs, aim at transferring knowledge, skills and competences to professionals, companies and employees working in CCIs in order to implement processes for the proper use of NFTs. This document intends to provide basic guidelines to VET organisations and trainers that want to structure similar training paths.

Learning Outcomes:

- To understand the concepts and functionalities of NFTs, including their creation, distribution, and monetisation within the Culture and Creative sectors.
- To recognise the benefits of integrating NFTs into CCIs, including intellectual property protection, business development, increased visibility, and competitive advantages, through case studies and real-world examples.
- To be able to access, use, and integrate NFTs into their professional practice, including the ability to mint, trade, and manage NFT assets effectively.

Target Group:

Trainers:

2 staff members experts in blockchain and digital transition for CCIs

Delivery: in total, 2 Workshops and 1 Final session will be organised online (or in person) in all the partner countries and will be based on the materials developed for the Pixel- Toolkit. The 3 different sessions will be organised in national languages. They will last 4 hours each and will be organised one month after the other so that the participants can better explore the topics presented and design concrete action plans.
